## REQUEST FOR TUITION WAIVER FOR NORTH CAROLINA RESIDENTS SIXTY-FIVE YEARS OF AGE AND OLDER

### Terms and Conditions

1. To be eligible for the tuition waiver for a particular semester, term or other recognized division of the academic calendar, the individual requesting such waiver of tuition must have attained the age of 65 prior to the commencement of such academic term, and must be a resident of North Carolina.
2. Class enrollment is contingent on course restrictions, prerequisites, and space available. These criteria are determined by the University.
3. "Tuition" shall mean the amount charged for registering for a credit hour of instruction and shall not be construed to mean any other special course fees, program fees (COE, PGM), other charges, or costs of textbooks. However, mandatory nonacademic fees will not be charged and students enrolled under the tuition waiver may not be entitled to the services, facilities, activities and programs supported by these fees. Students will need to verify availability with the various departments or facilities.
